

AACIP Planning Journal Agreement

I (We) the undersigned author(s), in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, hereby agree to assign, transfer and convey to the Alberta Association Canadian Institute of Planners (AACIP) all right, title and interest, including, without limitation, all right to possession, all copyright, and the right to file applications for registration of such rights, in Canada, in and to the work entitled: _____ (the "Work") which is submitted for consideration of publication in the AACIP Planning Journal, in the year _____.
